INVESTMENTS/FINANCIALS

Bruce provided the investment and financial reports. Investments are largely unchanged. Public housing amps and the cost center continue to have a surpluses. HCV continues to run an administrative surplus but a HAP deficit due to low utilization and underfunding from HUD. Cash flow remains sufficient to meet needs.

CAPITAL FUND REPORT

We have used \$922,085 of the awarded \$1,022,777 from the 2020 Capital Fund Grant. We have used \$1,040,950 of the awarded \$1,071,528 from the 2021 Capital Fund Grant. We have used \$368,926 of the awarded \$\$1,311,941 from the 2022 Capital Fund Grant. We have used \$68,700 of the awarded \$1,338,830 from the 2023 Capital Fund Grant. Current projects under contract include replacing doors at Indian Hills and the Asbestos Risk Assessment.

DIRECTOR'S REPORT

Jerry gave his executive director's report which is enclosed. Public housing occupancy is 98.%. There are 180 vouchers leased out between HCV and mainstream. CCH and Frederick Ball have a combined 126 vouchers leased between them. Demand for all programs remains high. Jerry has been sending staff to HOTMA and NSPIRE trainings. HUD has approved the use of the Morgan County Housing Authority to conduct HQS inspections over at Frederick Ball.
